Notice to the Market

Light S.A., publicly-held company, headquartered at Avenida Marechal Floriano, nº 168, segundo andar, corredor A, in the city of Rio de Janeiro, State of Rio de Janeiro, registered with CVM under No. 19879, enrolled with the Corporate Taxpayers' Register (CNPJ/MF) under No. 03.378.521/0001-75 ("Company"), hereby presents the clarifications requested by the Official Letter Number 375/2016-CVM/SEP/GEA-1, as follows:

Mrs. Ana Marta Horta Veloso,

1. *We hereby contact you regarding the information published on August 05, 2016 in Infomoney's website entitled "BB pode levantar R\$ 4,3 bi com venda no Patagonia; 7 resultados e mais notícias no radar", which contains the following allegation:*

According to Valor, Light (LIGT3) is currently studying the sale of its Generation Assets for Aliança Energia, a company with 1,158 MW of total installed capacity and stakes held by Vale and Cemig (CEMIG4)

2. *The Company's clarifications shall be filed in the Empresa.NET system, along with the transcription of this official letter.*

3. *Pursuant to number II, article 9 of law 6.385/76, and to CVM instruction number 452/07, the Superintendence of Relationship with Listed Companies shall apply a comminatory fine, **in the amount of R\$ 1,000.00** (one thousand reais), without prejudice to other administrative sanctions, in case the Company does not comply with the demand contained in this official letter, via e-mail, until 09:30 am of August 09, 2016, regardless of article 6 single paragraph of CVM instruction number 358/02.*

In view of the aforementioned inquiries, Light clarifies that, until this moment, there is no formal decision from its management regarding the sale of generation assets or agreement related to the terms and conditions of a possible sale, as well as any commitment that may link Light Energia S.A., Light's wholly-owned subsidiary, to the sale of assets to Aliança Energia or any other party.

Additionally, Light states that, in accordance to a Notice to the Market release on May 07, 2015 and March 30, 2016, as well as exposed in its Reference Form filed on May 25, 2016, Light Energia is "still evaluating the sale of its stake in Renova Energia S.A.". However, no formal decision has been taken or document has been signed related to this transaction.

Finally, we would like to highlight that the Company's management is continuously attentive to opportunities that may result in the generation of value for shareholders and will keep the Market dully informed on all updates related to this subject.

We put ourselves at your disposal to provide any further clarifications deemed necessary by CVM.
